WHEREAS, the Artist is a recognized professional artist;

WHEREAS, the Purchaser admires the work of the Artist and wishes to commission the Artist to create a work of art ("the Work") in the Artist's own unique style; and

WHEREAS, the parties wish to have the creation of this work of art governed by the mutual obligations, covenants, and conditions herein;

NOW, THEREFORE, in consideration of the foregoing premises and the mutual covenants hereinafter set forth and other valuable considerations, the parties hereto agree as follows:

shall use the Artist's professional judgment to deviate from the preliminary design as the Artist in good faith believes necessary to create the Work. The Purchaser shall have a right to inspect the Work in Progress upon reasonable notice to the Artist.

- 3. **Date of Delivery.** The Artist agrees to complete the Work within \_\_\_\_\_\_ days from the date the Artist and Purchaser agree on the design. This completion date shall be extended for such period of time as the Artist may be disabled by illness preventing progress of the Work. The completion date shall also be extended in the event of delays caused by events beyond the control of the Artist, including but not limited to fire, theft, strikes, shortages of materials, and Acts of God. Time shall not be considered of the essence with respect to the completion of the Work.
- 4. Shipping and Installation. Images and/or descriptions of the Work may not be reproduced, stored in a retrieval system, or transmitted in any form or by any means, electronic, mechanical, photocopying, recording, or otherwise, without prior written permission of the Artist, except that the Purchaser may, without the Artist's permission, include photographic images of the Work in the Purchaser's internal publications and on the Purchaser's web site.
- 7. **Privacy.** The Purchaser gives to the Artist permission to use the Purchaser's name, picture, portrait, and photograph, in all forms and media and in all manners, including but not limited to exhibition, display, advertising, trade, and editorial uses, without violation of the Purchaser's rights of privacy or any other personal or proprietary rights the Purchaser may possess in connection with reproduction and sale of the Work, the preliminary design, or any incidental works made in the creation of the Work.
- 8. **Integration.** This Agreement constitutes the entire understanding between the parties. Its terms can be modified only by an instrument in writing signed by both parties.
- 9. **Waivers.** A waiver of any breach of any of the provisions of this Agreement shall not be construed as a continuing waiver of other breaches of the same or other provisions hereof.
